

## **CERTIFIED LOGISTICS SUPERVISOR (CLS)** Certified Logistics Supervisor (CLS)



Supervisor logistik yang unggul menjadi tulang punggung operasional organisasi, memastikan keselamatan dan efisiensi dalam rantai pasok. Organisasi membutuhkan pemimpin logistik yang mampu mengelola pergudangan dengan presisi dan memahami dinamika industri logistik. In this way, participants not only gain global understanding, but also in accordance with the national logistics context.*

*CLS training equips logistics supervisors with six competency units, including warehouse operational systems, supplier selection and assessment, and logistics performance monitoring. It provides practical skills to deal with the complexity of daily tasks in logistics management.*

- Peserta pelatihan Supervisor Logistik dengan melampirkan sertifikat pelatihan terkait.

#### Ujian Sertifikasi:

- Uji Tertulis (90 Menit).
- Uji Presentasi & Wawancara (60 menit).

*Participating in training and passing the National CLS certification test from the Badan Nasional Sertifikasi Profesi (BNSP) is a strategic step to improve organizational capabilities. This certification not only confirms an individual's abilities, but also creates confidence that the logistics Supervisor has a recognized standard of competency, contributing to the progress and competitiveness of the organization in the competitive logistics market.*

1. Introduction to Logistics Management.
2. Basic Concepts of Inventory Management.
3. Warehousing Operational System.
4. Supplier Selection and Assessment Method.
5. Logistics work planning.
6. Logistics performance monitoring.

*Practitioners and academics as actors in logistics at the staff or supervisor level.*

#### Requirements:

- Min. associate degree with experience in logistics management at least 2 years (proven by a letter of work experience from the company), or bachelor degree (S1) with min. 3 months work experience.
- Logistics Supervisor training participants by attaching related training certificates.

#### Certification Exam:

- Written Test (90 Minutes).
- Presentation Test and interview (60 Minutes).
